# 1. Welcome and Introductions (PW):

PW opened the meeting and welcomed all members to the seventh UKAAP Steering Committee meeting. PW also noted the apologies sent from members unable to attend. Participants were then asked to introduce themselves. (A list of participant webpages can be found in Annex 1).

# 2. Review of Minutes and actions (PW) (Papers: UKAAP 7/01 and UKAAP 7/02)

This could be another way to further promote the research from the Social Sciences and Humanities (SSH) groups. DD agreed to inform NM who could then circulate information as and when it arises. In recent years SSH have been very successful in gaining funding; however with the changing landscape this could become more difficult. Further to the discussions, it was agreed that an initial step would be to write an article for <i>Planet Earth</i> on why polar science matters. #### 3. Steering Committee role in identifying, prioritising and championing 'new' polar research areas

The discussions focussed on some of the opportunities already available which include:

ARICE: Arctic Research Icebreaker Consortium – this is a programme funded by the EU to coordinate European icebreakers in the Arctic. ARICE joins the efforts of 14 partners from 12 different countries including Canada and the US. The project is due to start on 1<sup>st</sup> January 2018, with the aim to better coordinate the existing polar research fleet by offering transnational access through a call for proposals for ship time (first call set for March 2018). The grant will pay for access to the ship (travel, equipment etc.) but will not pay for the science; however this scheme will provide a great opportunity to do science in remote areas.

INTERACT — International Network for Terrestrial Research and Monitoring in the Arctic: This is another transnational access programme, funded by the EU and allows access to 77 research stations across the Arctic. The grant includes the travel and subsistence, logistical, technological and scientific support, and any specific training required, at the selected infrastructure. INTERACT Transnational Access calls will be open annually in the autumn for the following summer and winter seasons.

RRS *Sir David Attenborough*: DGV reported that this is on schedule, ready for October 2018. There are opportunities arising around this, with Ray Leakey from SAMS organising activities for polar science. There will be sea trials that will incorporate the testing of science equipment. In the northern winter 2019/2020, the RRS *Sir David Attenborough* will undertake a rehearsal cruise in the Antarctic to ensure that the vessel is able to complete the logistics role to carry out relief at the Antarctic stations. There will be opportunities to allocate some science time to focus on specific science areas. Ray Leakey is looking at ideas on how to allocate targeted science on this cruise. The first northern summer will be in 2020. It will be important to highlight that the RRS *Sir David Attenborough* will provide bigger capacity for multidisciplinary science and the science cruises will need to focus on this. This will impact on how BAS operates the cruises in terms of scheduling, allowing the opportunity to attach small projects to this.

International Ocean Discovery Program (IODP): JF commented that in the next two years there would be another IODP cruise around the Antarctic. 2019 call is now closed but later calls will open and the UK should be involved in this.

Arctic Circle Assemblies: The discussions also focussed on opportunities to showcase the UK in the Arctic, with mention of the Arctic Circle Assemblies providing good opportunities to highlight UK Arctic heritage and promote current and future activities. KD and HB to look at how we can continue to use these assemblies to promote UK activity in the Arctic.

Arctic Frontiers: DD noted that representatives from the Embassy in London strongly support UK involvement in this conference and are keen to make the UK's presence felt and to engage in a similar way as it does with the Arctic Circle Assemblies.

Arctic Science Ministers Meeting: HB reported that the next Arctic Science Ministerial meeting would be held in Berlin in 2018. This includes ministers from the Arctic Council countries but also from IASC countries. It is a good meeting, with MOSAiC and the UK-Canada bursaries programme developing out of the last meeting held in the

US in October 2016. This meeting provides an opportunity to sit round the table with the Arctic States. It will run over two days, with the first day being for science (there will be an opportunity to present at this). This will be hosted in Berlin, paid for by the EU.

There was wide-ranging discussion on the links between polar and non-polar research; how these areas crossed over; how to provide easier ways in to polar research; and how to use champions for polar work to make inroads into the non-polar community. Key questions included: what are we (the polar community) missing out on? And how do we want to target specific areas?

It was agreed that an action group be established (details in the action table above) to set the framework for how the discussion should happen, the agenda and overall approach. There was the potential for this session to be part/whole of the next UKAAP meeting, or for it to be a special (longer) session.

#### 4. Future Funding

The impact of Brexit on funding was discussed. It was noted that the Government's underwrite commitment guarantees payment of awards post Brexit, as long as the proposal has been submitted before the exit date. DGV commented that at a recent UK Research Office (UKRO) Information Day, the message to continue to apply for EU grants up until the exit deadline was strong. JF reported that it is expected that the European Polar Board will take over activities for EU-PolarNET. PW also noted that Brexit would not impact funding of INTERACT as the money will have been disbursed by the exit deadline.

A question was also raised about the success of the NERC/NSF agreement. H. Beadman agreed to look into the figures for what has been submitted and funded for polar science.

## ACTION: H. Beadman to investigate number of successful grants applied through the NERC/NSF scheme.

#### 5. Stakeholder reports

#### <u>Update on UK Government polar priorities and activities</u>

SD commented that the Polar Regions Department (PRD) are heavily promoting 'Global Britain and Polar activities' both internally and within UK Government, highlighting the UK's leading role in the Antarctic and the increasing role in the Arctic. The PRD are a seven-person team.

SD reported that plastics in the oceans is currently a subject high on the agenda for the PRD. The Sky Ocean Rescue campaign and TV programmes like the Blue Planet series have raised the profile of this issue with ministers. PRD are also working on ocean governance, Marine Protected Areas and the Blue Belt Programme. The Blue Belt Programme provides £20 million of funding over four years to support the provision of long-term protection of over 4 million square kilometres of marine environment across the UK Overseas Territories.

In terms of the Arctic, the key priority is engaging further with the Arctic Council. SD noted that there was a good session at the recent Arctic Council meeting where all Observers were encouraged to present on ways to deal with pollution in the Arctic. The UK has also been asked to speak at an Arctic Council Marine Working Group meeting in February 2018. SD reported that Iceland are keen to ensure that the Finnish priorities feed into the Icelandic two year Chairmanship which will commence in 2019.

SD reported that the UK Arctic Policy Framework document is currently being re-drafted and the PRD are in the process of consulting with other Government departments on the refresh, including the Arctic Office. The aim will be to launch this in early 2018.

In terms of the Antarctic, SD reported that the last ATCM took place in Beijing in May and that this had gone well. There had been an interesting debate on science into policy that had been led by the UK. There has been a focus in discussions on Marine Protected Areas; the MPA in East Antarctic was rejected however there is still a lot of support for more MPAs in Antarctica.

The PRD are also keen to look more into the impacts of tourism in the Antarctic and how this is developing and how this is likely to grow. SD reported that the PRD are keen to do more in this area and commented that any thoughts from the Social Science Community on this would be welcomed.

SD reported that the HMS Protector is still keen to support as much science as possible. If anyone is interested, please contact SD.

JF added that the Chileans have a big programme in Antarctica and are keen to collaborate with the UK on any terrestrial related projects. SD also noted that the Argentinians are keen to develop further UK collaborations.

#### Update from the UK Polar Network

Joe Cook attended the UKAAP SC meeting as the UK Polar Network (UKPN) representative. JC reported that a new committee for 2017-18 had been selected and consists of 19 members. The new President is Archana Dayal from the University of Sheffield, with Kyle Mayers as the Vice President. Joe Cook reported on the recent events that the UKPN had been involved in since the last UKAAP SC meeting in May 2017:

#### UKPN-Challenger Early career workshop

- Two workshops were run, one at the National Oceanography Centre (March 2017), Southampton, and the other in BAS in June 2017 to avoid clashes with the Arctic and Antarctic field seasons.
- There were over 30 attendees from PhD, Masters and postdoc level (March).
- The workshop focused on developing skills in project management in science and the importance of outreach.
- A number of group activities were organised: i) planning a field work activity (terrestrial or marine) with a budget and time scale, ii) groups were given challenges (e.g. injury on a ship, protected species on your sample site, polar bears in the area) which they then had to manage, iii) each group was given a polar topic (e.g. sea ice) and a target age group, and they had to deliver a 2 minute pitch for that group, and iv) the final activity was to design and project manage an outreach activity on their topic. They had to present this in a 5 minute presentation and a panel judged the projects, the best one was awarded £250.
- The winning activity was a soundscape called 'Sounds of Change: Greenland Ice Sheet Melt' which will be used in our classrooms and outreach activities.
- A similar format was used at BAS.

PW thanked JC and the UKPN for the report.

#### Update from NERC:

H. Beadman reported that all research councils will fall under one single body known as UKRI. This change will come into effect in April 2018. NERC will exist and operate as an individual centre with a budget from UKRI rather than direct from BEIS. There will be some changes in governance but this is not expected to impact on the science community initially; however there are likely to be some changes further ahead.

H. Beadman also reported that a panel would review the second call from the Changing Arctic Ocean Programme (which was a joint call with Germany) in January 2018. NERC are looking to award up to 10 grants.

RoSES: two projects have started with a third project to start shortly. There will be a second call for this programme but it is likely to be delayed.

MOSAiC: the call is open at the moment but closes in January 2018. There was a MOSAiC planning meeting in St Petersburg and 9 people from the UK went to this – travel money was provided by NERC as part of the commitment to MOSAiC.

THWAITES: this is a joint programme with NSF. The panel met in June 2017 and it is taking a while to award the grants but expect that the awards will be made in January 2018.

NEWTON: a new programme with Peru that will look at glacial retreat and its impact on water security and resilience to natural hazards. NERC are looking to hold a workshop in March 2018 for those interested in participating in this programme and will then put a call out for proposals in summer 2018.

### Arctic Office update:

*UK Arctic Science Conference*: HB reported that the Office was pleased to provide financial support to SAMS as hosts of the recent UK Arctic Conference. The Office also gave two presentations, including one on the UK Arctic Research Station. The Office also had a stand at the conference where it was able to distribute the various ARP and Arctic Office related products.

Arctic Circle Assembly: The Assembly takes place every October in Reykjavik, Iceland. This year there were 22 sessions/events with UK involvement which included a good session on innovation, communication, the Changing Arctic Ocean Programme and the new polar ship. This was well-attended (~ 70 people). There was also a joint session with WMO's World Climate Research Programme (WCRP) on AUVs and an event held with the Science and Innovation Network focussed on new technology and low carbon. The Arctic Office also had a stand with the various ARP reports and the infographic and UK Arctic video. This was followed by the Arctic Circle Forum event which was held in Edinburgh. Both Henry Burgess and Mark Inall (SAMS) spoke in the afternoon.

Science into Policy Report: Together with the NOC, the Arctic Office produced a science into policy report synthesising the key findings from the Arctic Research Programme. An event was held in London to launch this that was well attended by several representatives from Government departments. The Office has also produced an infographic which has been well received and distributed at several events.

The Arctic Office has been promoting #UKinArctic digital campaign which has been led by SIN Moscow. This has had about 2500 active engagements to date and is doing well.

*UK-Canada bursaries programme*: Last year this scheme funded 18 bursaries. Several of the recipients will attend the Arctic Change meeting in Canada in December 2017 to present their results. The Office has been successful in securing some more money from BEIS for the bursary programme to run again in the 2018/19 season. The call for applications will close on 5<sup>th</sup> January 2018.

The Arctic Office has been engaged in the recommissioning of the NERC Arctic Station. The Station will be the first of the Large Research Infrastructure facilities to be commissioned this way. We await the outcome of this process.

Concerning Russian activity, there will be two workshops for early career researchers that will be funded by BEIS early in 2018. The Arctic Office will also be hosting an event on the 5<sup>th</sup> December in Cambridge to discuss UK/Russia priorities and ways forward.

The Office is currently refreshing the website and aims to have a searchable database of current UK Arctic research embedded into the website. This will also require input from the community. H. Burgess also reported that the new 'Discovering the Arctic' website will be launched in the Spring of 2018. This is owned by the Royal Geographical Society and is the sister site of 'Discovering Antarctica', which has recently been redeveloped.

In terms of future activities, H. Burgess sits on the IASC action group looking at communication of science into policy and will present at Davos in 2018. The next Arctic Science Ministerial will be held in Berlin in October 2018 and the Office will look to support the UK delegation at this meeting.

#### Update from the All-Party Parliamentary Group (APPG)

DD gave a quick introduction to the All-Party Parliamentary Group for Polar Regions. This initiative was born out of a British delegation to the Arctic Circle in 2014. The focus of this group has been to put on events to inform and promote understanding of the Polar Regions and these are held roughly once every month. Usually between 50 and 100 people attend these events with MPs making up about 20% of the audience. In the summer of 2017, the APPG were successful in getting funding to take eight MPs up to Ny-Ålesund which went very well.

The APPG are holding an event on the 11<sup>th</sup> December with various representatives from indigenous communities speaking. The focus is to understand the opportunities and challenges of Arctic change. Nick Cox will be speaking at the Christmas event in London on the 19<sup>th</sup> December.

#### 6. UK Polar Science Conferences

PW noted the paper (UKAAP 7/04) that had been submitted by Finlo Cottier. He reported that the meeting had been successful and thanks to the support from the Arctic Office, they did not need to charge a registration fee. Finlo also thanked the Arctic Office for the support given in the lead up to and during the conference. The next Arctic Conference is due to take place in 2019 and will be hosted by Loughborough. Dates are being looked into and will be confirmed in due course. The Committee showed preference for the 11-13 September but this will depend on availability of meeting rooms.

It is expected that the next UK Antarctic Science meeting will take place in September 2018 in Durham, details to be released in due course.

There should be an alternating polar meeting each year, with the next Arctic meeting taking place in 2019, with an Antarctic meeting in 2020.

#### 7. New Deputy Chair:

A call went out after the last meeting for nominations for a Deputy Chair. Further to a short discussion, it was agreed by the Steering Committee that Professor Viv Jones will be the next Deputy Chair of the UKAAP SC.

#### 8. Membership:

PW reported that the new Steering Committee is now in place for the next term. As per the Terms of Reference, the Committee should look at refreshing the Committee by 1/3 every year. PW noted that there had been discussions regarding additional stakeholders on the Committee and that this should be discussed as part of the strategy meeting in May 2018.

#### 9. Next meeting:

The Committee agreed that the next meeting should be in London. NM to investigate possibilities and then circulate a doodle poll. The first week of May looked promising.

#### 10. AOB:

There was no other business. PW closed the meeting and thanked Stuart Doubleday and the FCO for hosting the meeting.
